

GIVING HEARTS DAY SWEEPSTAKES

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE CHANCES OF WINNING. ONE ENTRY PER PERSON PER FORM OF ENTRY IS ALLOWED. ELIGIBLE PARTICIPANTS MUST BE 18 OR OLDER AT THE TIME OF ENTRY AND MUST BE LEGAL PERMANENT RESIDENTS OF MINNESOTA OR NORTH DAKOTA. SWEEPSTAKES WINNERS ARE RESPONSIBLE FOR ALL APPLICABLE TAXES, LICENSES, INSURANCE, AND TITLES APPLICABLE TO THEIR PRIZES. SWEEPSTAKES SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS. VOID WHERE PROHIBITED.

Eligibility

This drawing is offered by Dakota Medical Foundation. There is no purchase, entry fee or payment necessary to enter, win, or obtain information about the sweepstakes. This sweepstakes is open to legal residents of North Dakota and Minnesota who are eighteen (18) years or older at the time of entry. Void where prohibited by law. Sweepstakes are subject to all applicable federal, state, and local laws. All employees and board members of Impact Foundation and Dakota Medical Foundation, along with those in their households, are ineligible to win any Sweepstakes prizes.

Timing/Sweepstakes Period

The sweepstakes starts January 10, 2022 at 8:00 a.m. (CST) and ends February 10, 2022 at 7:00 p.m. (CST).

Sweepstakes winners will be immediately contacted by phone to determine their eligibility and notify them of their winnings.

Conduct, Odds, Notification

The odds of winning a prize depends on the number of eligible entries received. Eighteen winners will be randomly drawn from a cumulative pool of entries February 7, 2022 through February 10, 2022.

If the winner is not an eligible (or responsive) recipient, the prize will be given to another randomly drawn entrant until eligible recipients have been awarded all the prizes. All entry records will be assigned a number and the winners will be randomly chosen by a computer drawing from the list of numbers assigned to the submissions.

Each winner will be notified by telephone with the information available with the mode of entry. Any winner notification returned as undeliverable will result in sweepstake forfeiture and an alternative winner may be selected.

The grand prize winner will be drawn and contacted to verify that they are willing and able to pay the tax, title, license, and all other fees and taxes applicable to receive the prize. If the winner is unwilling or unable to pay the necessary taxes and fees, their name will go back into the pool of entries. Names will be drawn until an eligible and qualified grand prize winner is found.

How to Enter

There are four methods of entry. There are no maximum entries per person.

All scheduled donations must be received by 11:59 p.m. (CST) on February 8, 2022 to be eligible. Multiple donations will result in a multiple sweepstakes entries. Giving Hearts Day Donors wanting to remain anonymous will automatically be opted out of the sweepstakes and can enter via another entry method including the non-purchase method of entry.

#2 Volunteer Pledge:

Pledge to Volunteer with a Giving Hearts Day Charity - During the Giving Hearts Day Sweepstakes period, visit <u>www.</u> <u>givingheartsday.org</u> and pledge to volunteer with a Giving Hearts Day charity by visiting their individual giving page and signing up to volunteer. Multiple pledges will result in multiple sweepstakes entries. Pledges must be posted by 11:59 p.m. (CST) on February 8, 2022 or made between 12:00 a.m. and 7 p.m. (CST) on February 10th, 2022 to be eligible.

#3 Goods Pledge:

Pledge to Donate Goods - During the Giving Hearts Day Sweepstakes period, visit <u>www.givingheartsday.org</u> and pledge to fill goods needs for a Giving Hearts Day charity by visiting their individual giving page and signing up to donate goods. Multiple donations will result in multiple sweepstakes entries. Pledges must be posted by 11:59 p.m. (CST) on February 8, 2022 or made between 12:00 a.m. and 7 p.m. (CST) on February 10th, 2022 to be eligible.

#4 Online Form Submission:

Complete an Online Form* - Use the link <u>https://app.smartsheet.com/b/form/b1cae95946d1446fa5df36e0b013f12d</u> to submit a short form. The form will include the participant's first name, last name, mailing address, phone number, email address, and answer the questions included in i. and ii. below. Must be submitted by Feb 10th, 2022 at 7 p.m. (CST) to be included. One entry per person.

- i. Why are you a Giving Heart and what does being a Giving Heart mean to you?
- ii. Which Giving Hearts Day nonprofit(s) are you passionate about and why?
- iii. If you are selected as a Giving Hearts Day 2022 Sweepstakes Golden Ticket winner, which Giving Hearts Day charity would you like the prize dollars to go to? (You can select only ONE charity).

Prizes

Runner up prizes (selected Feb 7th – 9th, 2022): One (1) PRX Performance Equipment Set (ARV: two thousand dollars \$2,000), One (1) Catalyst Medical Center Gift Card (ARV: one thousand dollars \$1,000), One (1) SuiteShots VIP Experience (ARV: one thousand dollars \$1,000), One (1) Coffee Lovers Package (1 bag of Thunder Coffee beans per month for one year) (ARV: two hundred fifty dollars \$250), One (1) Downtown Fargo Getaway + Breakfast at Radisson Blu (ARV: two hundred dollars \$200).

Golden ticket prizes (selected Feb 10th, 2022): Five (5) \$1,000 prizes with dollars donated to a charity of your choice, Five (5) \$2,500 prizes with dollars donated to a charity of your choice, One (1) \$5,000 prize with dollars donated to a charity of your choice, One (1) \$10,000 prize with dollars donated to a charity of your choice. Grand Prize (selected Feb 10th, 2022): One (1) 2022 Chevrolet Silverado 1500 LT Trail Boss pickup (ARV: fifty six thousand six hundred ten dollars (\$56,610)). YOU MUST PAY APPROXIMATELY \$3,540 (for North Dakota residents) or \$5,015 (for Minnesota residents) TO RECEIVE THIS ITEM. This cost is for tax, title, and license to be paid to the resident's state for the vehicle and it is the responsibility of the grand prize winner.

All Golden Ticket prize winners will have 30 minutes after the notification call to respond back to Dakota Medical Foundation at 701.271.0263 to provide one eligible Giving Hearts Day charity for the prize dollars to be donated to. If the recipient does not get back to Dakota Medical Foundation within 30 minutes, the prize dollars will be awarded to the Giving Hearts Day charity associated to the donor's donation, volunteer pledge, goods pledge, or indicated on the written form that was selected.

Publicity

All prize winners must agree to have their name and likeness used by Dakota Medical Foundation, Impact Foundation, and prize sponsors for use in social media, online, print, or television news coverage of Giving Hearts Day and for promotional material for their respective organizations.
